We are pleased to provide you with the NMLZO Application for Basic Certification. **To obtain the Application and Criteria** as well as the NMLZO Board of Directors List, and the FY 2011-2012 Membership Application form, please visit the New Mexico Municipal League Website at www.nmml.org and click on Subsections then Zoning Officials.

If you feel that you are at a point where you fulfill all of the requirements to acquire your Basic Certification, please complete the application and mail it back with the requested documentation. Please send your application packet to me, Linda Alire-Naranjo, at the New Mexico Municipal League, P.O. Box 846, Santa Fe, NM 87504-0846. **REMINDER: YOU MUST BE A CURRENT MEMBER OF NMLZO IN ORDER TO BE ELIGIBLE TO APPLY FOR BASIC CERTIFICATION.**

IF YOU WOULD LIKE TO BECOME CERTIFIED DURING THE UPCOMING SEPTEMBER NMLZO ANNUAL MEETING/WORKSHOP, PLEASE SUBMIT YOUR APPLICATION BEFORE OR BY WEDNESDAY, SEPTEMBER 7TH. NOTE: Don't forget to include all of the required documentation with your application. If you do not submit all of the required back-up documents by the deadline, this may delay your certification.

You can also apply at any point in time after the September Annual Meeting/Workshop to become certified. However, you will not be recognized in front of your peers until the next NMLZO Semi-Annual Meeting/Workshop in May 2012 (if you apply & approved prior that workshop).

SPECIAL NOTE: If your attendance at this September's NMLZO Annual Meeting/Workshop on September 21-23 will be considered your fourth NMLZO Workshop and you meet all of the other criteria in order to be eligible to receive your Certification then ***NOW IS THE TIME TO FILL OUT THE ATTACHED CERTIFICATION APPLICATION.*** Please carefully review the application and if you determine that you meet all of the criteria except for attendance at this September's Workshop, please fill out the application and make note that you will be completing your fourth workshop at the upcoming September meeting/workshop.

As a reminder, certification eligibility is based on a 100 point system of which 30 points are for attendance at four NMLZO Workshops. Upon submittal of your application *by September 7th*, and after review and approval, you may be able to receive your prestigious Certified Zoning Official (CZO) designation at the Thursday, September 22nd Luncheon during the NMLZO Annual Meeting/Workshop. **IMPORTANT NOTE: Please do not begin the application process until you have completed at least 3 of the 4 required NMLZO Workshops. However, we encourage you to estimate your points at this phase by referring to the application form to determine how many you're lacking.**
