PREFACE

New Mexico Chapter Laws are numbered in the order in which the Governor signs them.

The Governor has line-item veto power over bills containing appropriations. Partial vetoes are designated by striking through the deleted language.

The designation “CS/” or “FL/” before a bill means “Committee Substitute” or “Floor Substitute” indicating that a House or Senate Committee, or the entire House or Senate during a floor session, passed a rewritten version in place of the original bill.

The effective date of the signed bill is shown at the end of the chapter summary. Unless a specific effective date is listed in the bill, it is effective 90 calendar days after the close of the session (June 16th this year) or, if it is an appropriation, on July 1, the beginning of the new fiscal year. Bills with an emergency clause (*) become effective on the date signed by the Governor if passed by a two-thirds margin in each house.

Proposed Constitutional Amendments (CA) are in the form of joint resolutions passed by both houses and are numbered in order of final passage. They do not require the Governor’s signature, but are enacted if they receive voter approval by a majority vote at a statewide general or special election.

Joint Resolutions and Memorials are expressions of intent and usually request state agencies or committees to perform some task and report back to the Legislature. They have passed both houses, but do not require the Governor’s signature. Memorials are also expressions of intent or request for some action but need only pass the house in which they were introduced. They do not require the Governor’s signature.

All bills that were vetoed by the Governor this year are reported at the end of the Summary. A “pocket veto” designation means the Governor took no action on the bill within the required time limit. This effectively vetoes the measure.

2017 Summary of New Mexico Laws of Interest to Municipalities

1st SPECIAL SESSION (pv = partial veto)

Chapter 1 (pv)

***SS/CS/SB 1 SEVERANCE TAX BOND CHANGES** “Sweeps and swaps” numerous state appropriations and capital project fundings back to the General Fund. The bill authorizes the State Board of Finance to issue \$81.4 million in supplemental Severance Tax Bonds to help shore up the General Fund. The bill also transfers \$8 million from the New Mexico Finance Authority to the General Fund. The \$8 million comes from dedicated revenues from the Governmental Gross Receipts Tax distributed to the Authority. Effective 5/26/17.

Chapter 2 (pv)

SS/HB 1 SUPPLEMENTAL GENERAL APPROPRIATIONS ACT (Lundstrom) Appropriates money from the General Fund, other state funds, internal funds/interagency transfer for FY 18 for the operation of legislative functions and to restore funding for higher education. The bill appropriates more than \$763 million, \$19 million of which is for legislative functions, and \$744.8 million for higher education institutions. Appropriations include \$150,000 for a Capital Buildings Planning Commission Master Plan, \$99,600 for National Center for State Court dues and \$500,000 for student financial aid. Additional state funds include \$1 million from legislative cash balances for repairs, security and infrastructure upgrades in the Capitol Building, \$1 million from the University of New Mexico unrestricted cash balances for the Cancer Center at UNM, and \$500,000 for student aid. A special appropriation of \$1.2 million is made to the Administrative Office of the Courts for a shortfall in magistrate court leases. Of special note is a \$400,000 appropriation for a tax study to be performed in FY 18. Municipal tax structure will be a large part of the study. Effective 5/26/17.

Chapter 3 (pv)

SS/HB 2 TAX, FUND AND DISTRIBUTION CHANGES (Trujillo, J., Egolf, Trujillo, C) New material creates a “rainy day” fund by disbursing revenues in excess of a five-year average from the Oil and Gas Emergency Tax Fund to the Tax Stabilization Fund and repealing the Taxpayer Dividend Fund. Effective 7/1/18.

REGULAR SESSION

Chapter 1

HB 4 REVERT BALANCES OF CERTAIN FUNDS (Lundstrom) The bill would require all FY 2017 balances of the Insurance Operations Fund, the Fire Protection Fund, the Fire Protection Grant Fund and the Law Enforcement Protection Fund to revert to the General Fund rather than carry forward for spending in FY 2018. The bill aligns each of the funds’ revenue with spending during the same fiscal year going forward in FY 2018; the bill temporarily halts spending from the Fire Protection Fund to the Fire Protection Grant Fund, but transfers would begin again in FY 2019 at the 40.2% rate; estimated total reverting to the General Fund is \$10.7 million. The House Floor Amendment requires the State Fire Marshal to coordinate with the New Mexico Municipal League and others to determine and certify the needs of municipal fire departments when developing the schedule for periodic allotments in FY 2018, to ensure that debt obligations are met on a timely basis, to ensure the smooth operation of the fire departments as they shift to

periodic allotments and to assist in the change to accrual accounting for purposes of the Fire Protection Fund. The State Fire Marshal is to report to the Legislative Finance Committee on the schedule developed by July 1, 2017 and on the full transition to accrual accounting by June 30, 2018. Effective 1/31/17.

Chapter 2 (pv)

SB 113 **REDUCE APPROPRIATIONS & TRANSFER FUNDS (Smith, Cisneros)** The bill reduces General Fund appropriations for the current fiscal year, transfers cash balances in certain funds to the General Fund, appropriates other state funds to offset some of the General Fund reductions, provides authority to reduce agency operating budgets and transfers remaining Tobacco Settlement Fund cash balances to the General Fund. Effective 1/31/17.

Chapter 3

***CS/SB 114** **SCHOOL DISTRICT CASH BALANCES** Reduces the school districts' and charter schools' 2017 state equalization guarantees by \$46.1 million. Effective 1/31/17.

Chapter 6

HB 60 **BROADBAND INFRASTRUCTURE DEVELOPMENT (Trujillo, C., Candelaria)** Amending §5-10-3; the bill amends the definition section of the Local Economic Development Act (LEDA) to include a definition for “broadband telecommunications network facilities” and expands the definition of “economic development project” or “project” to include infrastructure for rights-of-way for the placement of new broadband telecommunications network facilities. Effective 6/16/17.

Chapter 7

CS/HB 113 **STATEWIDE BROADBAND NETWORK** Amends §9-27-3 to define a “telecommunications network” as the physical and logical components and all associated infrastructure used in transporting, routing, aggregating and delivering voice and data information from computer and telecommunications systems in one location to peer systems in another; amends §9-27-6 to authorize the Secretary of the Department of Information Technology as the state’s Chief Information Officer (CIO) to develop a state-wide broadband network plan in conjunction with educational institutions, political subdivisions of the state, tribes and Indian nations and telecommunications providers; the network may apply for reimbursements under the Federal Telecommunications Act and charge institutions for participating; Indian nations, tribes and pueblos may participate in exchange for rights-of-way; departments, institutions and agencies participating in the telecommunications network shall be charged a pro rata and equitable share of the total monthly cost of the service; creates the Telecommunications Network Fund; repeals Laws 2007, Chapter 888, Section 3. Effective 6/16/17.

Chapter 9

HB 162 **LOCAL OPTION FOR LIQUOR SALES HOURS (Johnson, Lundstrom, Alcon, Garcia)** Amends §60-7A-1; the bill provides that McKinley County or a municipality in that county may by ordinance restrict the hours of package sales. Current law allows package sales between 7 a.m. and 11 a.m. Monday through Saturday, but sales may be restricted during these hours by the municipal or county ordinance; reduces the hours during which a municipality or county may restrict sales to between 7 a.m. and 10 a.m. Effective 7/1/17.

Chapter 11

HB 29 **CARLSBAD BRINE WELL AUTHORITY AND FUND (Brown)** New material creates the Carlsbad Brine Well Remediation Advisory Authority; the Authority is a governmental entity of

the state; the mayor of the City of Carlsbad or his designee is to serve as chair along with seven other members, including the Secretaries or their designees of the Energy, Minerals and Natural Resources Department, the Environment Department, the Department of Transportation, the State Engineers Office, the Attorney General and the manager of the Carlsbad Irrigation District; the Authority shall recommend policy for and advise the Oil Conservation Division of the Energy, Minerals and Natural Resources Department on the remediation of the Carlsbad brine well; creates the Carlsbad Brine Well Remediation Fund that is to be administered by the Energy, Minerals and Natural Resources Department; sunsets the Authority as of July 1, 2029. Effective 7/1/17.

Chapter 14
HB 97

MUNICIPAL LIFE INSURANCE BENEFITS TRUST (Adkins, Ely) Enacts new material; the bill authorizes a municipal treasurer, with the advice and consent of the municipal board of finance, to establish a municipal post-employment life insurance benefits trust and act as the trustee of the trust. The money in the trust is dedicated exclusively to funding post-employment life insurance benefits for municipal retirees. Effective 6/16/17.

Chapter 20
SB 75

DEFERRED COMPENSATION CHANGES (White, Gonzales) Amends §10-7A-3; local public employees may participate in a deferred compensation plan selected by their local public body employer after it takes formal action conforming to board requirements; the type of deferred compensation investment options that may be approved include mutual funds, including stock, bond or capital preservation funds; local public employees may participate in deferred programs upon the filing of a local public body's participation agreement, conforming to board requirements. Effective 6/16/17.

Chapter 22
***SB 44**

WATER PROJECT FUND PROJECTS (Cervantes) Authorizes the New Mexico Finance Authority to make loans or grants to the following municipal qualifying water projects: **Anthony** – flood prevention project; **Carlsbad** – water conservation or treatment, recycling and re-use; **Cimarron** – water storage, conveyance and delivery; **Clovis** - water conservation or treatment, recycling and re-use; **Columbus** – water storage, conveyance and delivery; **Eagle Nest** – water storage, conveyance and delivery; **Elida** - water storage, conveyance and delivery; **Jal** - water conservation or treatment, recycling and re-use; **Portales** - water storage, conveyance and delivery; **Red River** - water storage, conveyance and delivery; **Santa Fe** - water storage, conveyance and delivery; **Santa Rosa** - water storage, conveyance and delivery; water conservation or treatment, recycling and re-use; and **Truth or Consequences** - water storage, conveyance and delivery. **Law Without Signature.** Effective 3/18/17.

Chapter 27
HB 110

BENCH WARRANT JURISDICTION (Garcia Richard) Amends §35-15-4; the bill allows law enforcement officers in counties contiguous to the county in which a violation of a municipal ordinance has been alleged, to serve a municipal court process or make an arrest for the municipality, with the exception of parking violations. Effective 7/1/17.

Chapter 29
HB 256

DRINKING WATER SYSTEM FINANCING (Powdrell-Culbert, Herrell) Appropriates \$1.8 million to the drinking water state revolving loan fund, a non-reverting fund, to match federal funds for the federal Safe Drinking Water Act and to comply with the provisions of the Drinking Water State Revolving Loan Fund Act. Effective 7/1/17.

Chapter 30 HB 218

LITTER CONTROL & LANDSCAPE BEAUTIFICATION (Dow) The bill amends the Litter Control and Beautification Act to create the 11-member New Mexico Clean and Beautiful Advisory Committee with statewide representation appointed by the Tourism Commission, that supplants the Litter Control Council and is responsible for advising the Tourism Commission on activities that conform to the federal Keep America Beautiful Act and to inform the Commission of litter control activities that will help support keeping the state litter free and beautiful. The bill repeals §67-16-10. Effective 7/1/17.

Chapter 32

CS/SB 155

WORKERS' COMP BENEFIT CLARIFICATION Amends §§52-1-25.1 and 26; if the worker is responsible for the separation from employment and that separation is unrelated to the on-the-job injury, the worker shall not receive temporary total disability; if the worker is responsible for the separation from employment and that separation is unrelated to the on-the-job injury, the permanent partial disability rating shall be equal to the impairment rating. Effective 7/1/17.

Chapter 35

HB 9

LAW ENFORCEMENT TOURNIQUET TRAINING (Ruiloba) New material creates a section in the Law Enforcement Training Act to require tourniquet and trauma kit training be part of the curriculum in each basic law enforcement training class and as a component of in-service law enforcement training each year for certified police officers. The Academy, in coordination with certified regional law enforcement training facilities, shall provide tourniquet and trauma kits to each cadet who graduates from the Academy or regional training facility and to each previously certified police officer who attend a certification-by-waiver course; the Academy shall provide hands-on training to all officers using the tourniquet and trauma kits and may produce a training video; provides a distribution from the Law Enforcement Protection Fund of \$24,500 annually to the Academy to carry out the training provisions.. Effective 7/1/17.

CS/HB 219

Chapter 46

HB 249

COLLEGE SPECIAL EVENT GROSS RECEIPTS (Martinez, R., Ferrary, Small) Amends §7-9-104 to increase the time frame from 2007 to 2022 for a gross receipts tax deduction for non-athletic special events held at a venue that is located on a campus of a post-secondary educational institution within 50 miles of the New Mexico border and accommodates at least 10,000 persons. Effective 6/16/17.

Chapter 49 HB 262

SUNDAY LIQUOR SALES ON DECEMBER 31 (Trujillo, J.) Amends §60-7A-3; the bill authorizes the Regulation and Licensing Department to issue permits to licensees for sales of

liquor on December 31 from 11 a.m. to 2 a.m. the next morning when that day falls on a Sunday. Effective 6/16/17.

Chapter 50

*HB 268

PUBLIC PROJECT REVOLVING FUND PROJECTS (Lundstrom, Powdrell-Culbert)

The bill authorizes the New Mexico Finance Authority to make loans from the Public Project Revolving Fund to the following municipalities for building, equipment, infrastructure, debt refinancing, road, land acquisition, water, wastewater, water rights and solid waste projects:

Alamogordo; Bayard; Bosque Farms; Capitan; Carlsbad; Chama; Cimarron; Cloudcroft; Clovis; Columbus; Corrales; Deming; Dexter; Eagle Nest; Elephant Butte; Elida; Farmington; Fort Sumner; Hagerman; Hobbs; House; Jemez Springs; Lake Arthur; Los Ranchos de Albuquerque; Mountainair; Questa; Red River; Reserve; Rio Rancho; Roswell; Santa Clara; Santa Fe; Santa Rosa; Springer; Truth or Consequences; Tularosa; Virden; Willard; and Williamsburg. Effective 4/6/17.

Chapter 54

HB 302

REDEFINING “AUTOCYCLE” (Trujillo, C.) Amends §66-1-4.1; the bill amends the

definition of “autocycle” in the Motor Vehicle Code to include that these three-wheeled motorcycles be manufactured to meet federal motorcycle safety standards. Effective 6/16/17.

Chapter 59

CS/HB 370

OPIOID OVERDOSE EDUCATION Enacts new material; the bill requires state and local law enforcement officers to carry opioid antagonists to treat cases of opioid overdose and to be trained in how to use the antagonists. Also inmates of a corrections facility or detention center who have substance abuse disorders are required to be trained on how to administer opioid antagonists upon release after serving a term for a conviction. The mandates of the original bill are softened in the substitute bill to require providing an opioid antagonist only as agency or service resources permit. Effective 6/16/17.

Chapter 63

HB 408

TAX LIABILITY CHANGES & DEFINITIONS (Trujillo, C.) Amends

Chapter 70

SB 51

OFF-ROAD VEHICLE LICENSE AND PLATES (Neville) Amends §66-1-4.19 to add to the definitions that is a vehicle plate that are exempted under the Motor Vehicle Code; new material authorizes the department to issue off-highway plates to people who intend to use the vehicle on paved streets; if authorized by a local authority or the State Transportation Commission, a person may operate an off-highway vehicle on paved street if the operator wears eye protection and if under 18, wears a helmet; an operator of off -highway vehicles on paved streets is subject to the requirements for operators of moving and parked vehicle under the Motor Vehicle Code

requirements for operators of moving and parked vehicles under the Motor Vehicle Code. Prohibits a person from operating an off-highway vehicle in excess of 10 miles per hour on a public roadway. Effective 7/1/17.

Chapter 75**SB 76**

MOVE OVER OR SLOW DOWN FOR HAZARD LIGHTS (White, Gonzales) Amends §66-7-332; upon approaching a stationary authorized emergency vehicle, including a recovery or repair vehicle displaying flashing emergency or hazard lights, the driver, if reasonably safe to do so, drive in a lane not adjacent to the stationary vehicle, decrease the speed that is reasonable and prudent or drive in a lane not adjacent to the stationary vehicle at a reasonable speed and be prepared to stop. A recovery or repair vehicle standing on a highway for the purpose of removing, and actually engaged in removing a disabled vehicle and while engaged in towing a disabled vehicle may display flashing lights in any color except red. Effective 6/16/17.

Chapter 89**SB 308**

PRC TO FACILITATE RURAL BROADBAND SERVICE (Padilla) Amends §63-9H-6; the Public Regulations Commission shall adopt rules that establish and implement a broadband program to provide funding to eligible telecommunications carriers for the construction and maintenance of facilities capable of providing broadband internet access service; authorizes the Commission to establish a surcharge as a percentage of intrastate retail public telecommunications services revenue or as a fixed amount applicable to each communication connection; sets a minimum of \$5 million a year to be dedicated to the program; sets a cap of \$30 million per year for total program costs. Effective 6/16/17.

Chapter 92**CS/SB 339****& 419**

MULTIPLE SOURCE CONTRACT DOLLAR LIMITS Amends §13-1-154.1; raises the limits for multiple architectural or engineering service contracts for state agencies and local public bodies from \$2 million to \$6 million over a four-year period; raises the limits for multiple indefinite quantity construction contracts for state agencies and local public bodies to \$10 million over a three-year period. Effective 7/1/17.

Chapter 96**CS/SB 411**

TELECOM SURCHARGES ON MODERN TECHNOLOGIES Amends §63-9F-11 to impose a telecommunications relay surcharge of .33 percent on the gross amount paid by customers for intrastate telecommunications services provided in the state; includes customers for retail pre-paid mobile telecommunications services which must be paid at the time of purchase; the surcharge is the liability of the customer; surcharge applies to a home service provider providing intrastate mobile telecommunications services. Effective 7/1/17.

Chapter 114**HB 415**

STATE AGENCY WASTEWATER PROJECT FINANCING (Crowder, Martinez R.) Amends §§§§74-6A-2, 74-6A-3, 74-6A-8, 74-6A-9 and 74-6A-12; the bill amends the Wastewater Facility Construction Loan Act to include state agencies along with local authorities as entities that are able to access financial assistance pursuant to the Wastewater Facility Construction Loan Act to construct or improve wastewater systems. Effective 7/1/17.

Chapter 118**SB 4**

CARLSBAD BRINE WELL AUTHORITY AND FUND (Leavell) New material creates the Carlsbad Brine Well Remediation Advisory Authority; the Authority is a governmental entity of the state; the mayor of the City of Carlsbad or his designee is to serve as chair along with seven other members, including the Secretaries or their designees of the Energy, Minerals and Natural Resources Department, the Environment Department, the Department of Transportation, the

State Engineers Office, the Attorney General and the manager of the Carlsbad Irrigation District; the Authority shall recommend policy for and advise the Oil Conservation Division of the Energy, Minerals and Natural Resources Department on the remediation of the Carlsbad brine well; creates the Carlsbad Brine Well Remediation Fund that is to be administered by the Energy, Minerals and Natural Resources Department; sunsets the Authority as of July 1, 2029. Effective 7/1/17.

Chapter 122

CS/SB 46

E911 SURCHARGES ON COMMUNICATIONS SERVICES Amends §63-9D-3 to apply the 911 emergency surcharge to all communications services providers; authorizes a county to adopt an ordinance making it a violation for a person to knowingly dial 911 for the purpose of reporting a false alarm, making a false complaint or reporting false information; applies the 911 surcharge to pre-paid wireless sales of 1.38 % of the gross value of each transaction and sets limitations of liability for pre-paid wireless sellers; the retail transactions considered as “minimal” worth \$5 or less offering 10 minutes or less of talk time are not required to be subject to the pre-paid enhanced 911 surcharge. Repeals §63-9D-4.1. Effective 6/16/17.

Chapter 127

SB 233

SANITARY PROJECT NEW ASSOCIATION STANDARDS (Griggs, Fajardo) Amends §3-29-5; a new association shall not be formed under the Sanitary Projects Act after July 1, 2017 unless the association will serve at least 15 connections or a population of at least 25 people for at least six months of the year. Effective 6/16/17.

Chapter 133

***CS/SB 362**

CAPITAL OUTLAY REAUTHORIZATIONS Reauthorizes or re-appropriates capital projects made in prior years. See attached chart. Effective 4/7/17.

Resolutions and Memorials

CS/HJR 8

CA: STATE ETHICS COMMISSION (Dines, Small, McCamley, Ely, Steinborn) Proposes to amend the New Mexico Constitution to add Article 25 that creates the State Ethics Commission. Five members would be appointed by the Governor, the Speaker and House Minority Leader, Senate President Pro Tem and Senate Minority Leader and those would choose the sixth and seventh members. The Commission may initiate, receive, investigate and adjudicate complaints alleging violations of, and issue advisory opinions concerning, standards of ethical conduct and other standards of conduct and reporting requirements. The Commission may require attendance or the production of records and other evidence by subpoena as provided by law. Passed House, Senate.

HM 1

REGIONAL WATER PLANNING PROCESS IMPROVEMENTS (Salazar, T.) Requests the Interstate Stream Commission to convene a task force to make recommendations to correct deficiencies in current state and regional water planning programs, one of which is the lack of local government and resident involvement in the process of updating current regional water plans. Signed.

HM 29

NM COMPLETE STREETS EFFORTS (Small, Maestas Barnes) Congratulates the leadership and accomplishments of local and tribal governments, agencies and team members that are committed to the safety of all users of roadways in promoting and implementing

complete streets throughout New Mexico; that complete streets be recognized for its understanding that transportation is about moving people and connecting, supporting and building vibrant communities. Signed.

Notwithstanding the provisions of the Art in Public Places Act to the contrary, the unexpended balance up to one million two hundred fifty five thousand two hundred dollars (\$1,255,200) of severance tax bond appropriations remaining in the art in public places fund shall not be expended for the original purpose but is appropriated to the state museums improvements and exhibits fund for capital expenditures by the cultural affairs department in fiscal years 2017 through 2019 for repairs and upgrades to state museum facilities and to exhibitions at state museums statewide, in accordance with Section 9-4A-22 NMSA 1978. Any unexpended or unencumbered balance remaining at the end of fiscal year 2019 shall revert to the art in public places fund.
