**Active Membership \$75.00:** Each municipality, county or other governmental subdivision of the State of New Mexico (hereinafter “Airport Sponsor” which owns or operates a Public Use Airport is eligible for ONE ACTIVE MEMBERSHIP in the Association. The individual assigned the responsibility of airport management by the Airport Sponsor shall be designated the ACTIVE MEMBER representing that Airport Sponsor.

**Alternate Membership \$75.00:** Other individuals officially designated by the Airport Sponsor as part of the Airport Management system at their Airport, such as members of an Airport Authority or Advisory Board, shall be considered ALTERNATE MEMBERS of the Association.

**Associate Membership \$75.00:** Any interested individual shall be eligible for membership as an ASSOCIATE MEMBER in this association. The board of directors shall determine the eligibility, subject to Article IV, Section 1, C of these by-Laws. Governmental Interested individuals whose employment with the State or Federal Governments prohibits membership in the Association, but who, in their official capacity, wishes to be informed of the Association’s activities and schedule, may be included in the Association’s roster as an associate member for purposes of information and coordination only. Such individuals may not be directly associated with airport management.

**Corporate Membership \$250.00:** Any interested individual, partnership, corporation or other legal entity which has a business or other professional interest in airports and aviation shall be eligible for membership as a CORPORATE MEMBER in this association. Corporate Members shall be authorized to advertise their products and/or services during the Association’s meetings in a reasonable manner as determined by the Board of Directors.
