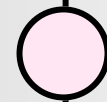
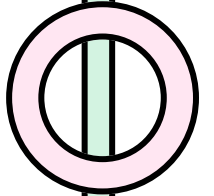

○ Pandemic Federal Funding



- American Rescue Plan Act (ARPA)
 - Replace lost public sector revenue - up to \$10 million.
 - Support the COVID-19 public health and economic response.
 - Provide premium pay for eligible workers performing essential work.
 - Invest in water, sewer, and broadband infrastructure.
 - Broad latitude provided for specific uses and procurement.
- Funds must be used for costs incurred on or after March 3, 2021 and obligated by December 31, 2024.

○ Pandemic Federal Funding



- Infrastructure Investment and Jobs Act (IIJA)
 - Total Funding is \$1.2 Trillion, with \$567 Billion in “New Money”
 - Total Funding provided over 5 years.
 - Total Funding provided in three categories of the federal budget - Highway Trust Fund, Guaranteed Appropriations and General Fund.
 - Funding provided through eight existing Federal Agencies.
 - New Mexico’s Share is estimated at \$3.76 Billion
 - Aviation; Bridges; Roads; Wastewater; Drinking Water and Dams

Existing Federal Funding Sources

- Natural Resource Conservation Service (NRCS)
 - Watershed and Flood Prevention Operations Program (WFPO);
 - Requires a Watershed Conservation Plan
 - Can be up to 100% Grant.
 - Watershed Rehabilitation Program (WRP);
 - Emergency Watershed Program (EWP);
 - Environmental Quality Incentives Program (EQIP);
 - Regional Conservation Partnership Program (RCPP)

Existing Federal Funding Sources

- Federal Emergency Management Agency (FEMA)
 - Hazard Mitigation Grant Program (HMGP);
 - Funding tied to federal disasters in NM.
 - 75% grant
 - Flood Mitigation Assistance (FMA);
 - Restricted to communities with a flood insurance program.
 - 75% grant
- Building Resilient Infrastructure and Communities (BRIC)
 - National competition, 75% grant.

Existing Federal Funding Sources

- Federal Highway Administration (FHWA)
 - Metropolitan or Rural Planning Organization (MPO/RPO)
 - Transportation Improvement Program (TIP)
 - 84% grant.
 - Transportation Alternative Program (TAP)
 - 84% grant.
 - Highway Safety Improvement Program (HSIP)
 - Up to 90% grant.

Existing Federal Funding Sources

- Environmental Protection Agency (EPA)
 - Clean Water State Revolving Loan Fund (CWSRF)
 - Drinking Water State Revolving Loan Fund (DWSRF)
 - These are typically low interest loan programs.
 - Both of these programs are more competitive when interest rates are high.
 - Recent funding through IIJA provides up to 50% grant.

Existing Federal Funding Sources

- US Army Corps of Engineers (USACE)
 - Continuing Authority Programs (CAP)
 - Focuses on Flood Mitigation projects.
 - Upper limit of \$10 million.
 - 66% Grant.
 - Section 14 - Erosion Mitigation
 - Environmental Infrastructure (Section 595 & 593)
 - Similar focus as CAP, but 75% grant.

Existing Federal Funding Sources

- Bureau of Reclamation (BOR)
 - Water SMART Program
 - Water and Energy Efficiency Grants
 - Small-Scale Water Efficiency Projects
 - Water Marketing Strategy Grants
 - Drought Response Program
 - Cooperative Watershed Management Program (CWMP)
 - Smaller grants, typically 50%.

Existing Federal Funding Sources

- Land & Water Conservation Fund
 - Can be used to purchase land.
 - NM State Conservation & Outdoor Recreation Plan (SCORP)
 - 50% grant.
- Urban Waters Federal Partnership (UWFP)
 - Coalition of Federal, State and Private Entities
 - Available in the Middle Rio Grande
 - Grant & Match varies.
