## NEW MEXICO LEAGUE OF ZONING OFFICIALS SCHOLARSHIP ELIGIBILITY REQUIREMENTS

The New Mexico League of Zoning Officials is offering a limited number of scholarships to our membership to attend the NMLZO Semi-Annual Meeting/Workshop. It will be held May 3<sup>rd</sup> - 5<sup>th</sup> at the Albuquerque Marriott Uptown. The purpose of these scholarships is to permit eligible individuals with a demonstrated need to attend the Workshop. A *Full Scholarship* will cover the registration fee for the workshop, and lodging (2 nights), however you will be responsible for your own transportation, and meals, if not included with the workshop registration. A *Partial Scholarship* will cover the registration fee for the workshop, and you will be responsible for your own overnight accommodations, transportation, and meals not included with the workshop registration.

You may apply for a scholarship if you meet the following requirements:

1. Candidate must be a member in good standing with the New Mexico League of Zoning Officials (Member for Fiscal Year 2016-2017). This also applies to group memberships.
2. Candidate must submit a letter from his/her Supervisor or Governing Body permitting attendance to the Workshop.
3. Candidate must include a two (2) page (max.) narrative including why they would like to attend, what they feel they will receive by attending, and a brief synopsis of their job duties.

If you meet the basic criteria, please complete the scholarship application, attach the necessary documents and RETURN THEM TO THE NEW MEXICO MUNICIPAL LEAGUE NO LATER THAN APRIL 19, 2017.
